World Sight Day – the **most important advocacy** and **communications** day in the eye health calendar. This year's call to action was "Hope in Sight" and 2020 appears to have been the biggest World Sight Day ever, certainly in terms of media coverage. In Africa the day was well celebrated with multiple press events across the continent. Activities organised by the eye health sector engaged with Government Ministries, health facilities and training institutions to raise awareness around eye health. Media coverage included local television and radio reporting on World Sight Day events as well as talk shows and promotional spots on the causes of visual impairment and blindness. #### **1.2 UN Event discusses accelerating vision for everyone**

Political Leaders, UN Ambassadors, Head of UNICEF and Civil Society groups join HRH The Countess of Wessex for a United Nations event to discuss accelerating Vision for Everyone.

In recognition of World Sight Day, Royalty, political leaders, United Nations (UN) Ambassadors and the Executive Director of UNICEF joined with leading civil society organisations globally to hold a virtual United Nations event to discuss the issue of eye health and importance to achieving its the UN Sustainable Development Goals (SDGs) and a recovery from Covid-19.

#### 1.3 Updated Vision Atlas shows 1.1 billion people have vision loss

To mark <u>World Sight Day 2020</u> the International Agency for the Prevention of Blindness (IAPB) has updated its <u>Vision Atlas</u> with new estimates on the magnitude, projections and causes of vision loss from <u>The Vision</u> <u>Loss Expert Group (VLEG)</u>.

The IAPB Vision Atlas is a wealth of information relevant to policy makers, health planners, eye health professionals, NGOs, patient groups and advocates. Given that so much of avoidable sight loss is a consequence of inequity and lack of access for the most disadvantaged members of our global community, the



IAPB Vision Atlas is an important resource for those responsible for achieving universal health coverage and the <u>implementation of the Sustainable Development Goals</u>. The 2020 update provides a rich mix of data, narrative and interactive presentation tools that make it easy to understand and present complex data sets to a broad audience. #### 2. IAPB NEWS

#### 2.1 Clearly to merge into IAPB

On 4 January 2021, we are delighted to announce that **Clearly**, the charity founded in 2016 by James Chen to raise the profile of vision among world leaders, **will merge into the International Agency for the Prevention of Blindness** (IAPB).

In a sign of the growing strength of the sector and progress that has been made on the issue over the last five years, the move is designed to combine the two organisations' advocacy and campaigning expertise and bring renewed pressure on global actors and governments to end the vision crisis.

Peter Holland, Chief Executive of the IAPB, and James Chen say today that the unprecedented move marks the "next exciting phase in the battle to deliver vision for everyone". It combines the long-established efforts of the IAPB and its members to counter avoidable blindness and promote eye health with governments around the world with the successful campaigning work of Clearly to highlight the case for clear vision for all within organisations such as the United Nations and Commonwealth.

Along with his ongoing interests as Founder of <u>Vision for a Nation</u> and <u>Adlens</u>, James Chen will continue to play an active role in the vision sector following the merger as Global Ambassador for IAPB – making the case for concerted global action at scale.

#### 2.2 Virtual Launches of the World Report on Vision

Following the launch of the World Report on Vision in October 2019, IAPB had committed to work with the World Health Organization (WHO) to coordinate over 50 <u>World Report on Vision country</u> <u>launches</u>. Since the launch of the World Report on Vision, IAPB have convened eight successful launches. These launches have been critical to the implementation process of the report and have enabled key stakeholders to discuss country-specific challenges and agree to key actions moving forward.

The COVID-19 pandemic has caused the postponement of many of the planned launches, however, the USA and Canada launches have gone ahead virtually. These virtual launches have been a resounding success and have been as equally engaging as the pre-COVID launch counterparts.



#### 3. WHO NEWS: The WHO Academy



A new focus on learning for impact and building competencies to make the world a healthier place. This is the thinking behind the World Health Organization's new WHO Academy, a stateof-the-art training institution that aims to bring the lifelong learning revolution to the health sector and reach 10 million

learners around the world by 2023.

As a centre for delivering advanced digital and classroom training to health workers and others around the world, the WHO Academy will be a game changer for lifelong learning in health.

Scheduled to launch its first online courses in May 2021 and headquartered at a futuristic campus in Lyon, France, the Academy will be a globally accessible school for the future, combining the latest technologies in digital and remote learning with advancements in adult learning science to offer innovative, personalised and multilingual training that meets priority needs. #### 5.1 London School of Hygiene & Tropical Medicine Online Short Course: International Eye Health - 9-12 November 2020
