This goal of this course is to enable eye care professionals to be able to deliver gender appropriate services that are locally informed and tailored to address the specific local issues that are barriers to achieving gender equity in eye health programming. Whilst focussing on improving the eye health outcomes of women and girls this course is relevant to broader sustainable development programming in Pakistan.

Student Learning Outcomes

On the successful completion of this course students should be able to:

- 1. Advocate to local stakeholders for the provision of equal opportunity for women to access and benefit from eye health services, education opportunities and related programs
- 2. Identify and begin to address areas within their organisation that could be improved to include, mentor and provide opportunities at all levels for women.
- 3. Evaluate local eye health services and programs from a gender perspective, (including understanding cultural, economic, institutional, health and education systems and political environment) identifying barriers and enablers to gender equity in the local setting (using tools provided).
- 4. Begin to use gender responsive program design, planning & budgeting tools to make changes to existing services/programs or begin new eye health initiatives.
- 5. Identify potential relevant local and/or global partnerships to further facilitate gender equity in eye health

Topics

This course will be delivered in a blended learning format, which includes 2 hours online and a 2 day face-to-face workshop. The course will cover the following topics:

- An introduction to Gender, Development & Health
- Framework for Gender Evaluation
- Gender equity in Eye Health Services
- Gender Equity in Eye Health Education & Research
- Gender Equity within the workplace
- Partnerships & Advocacy

It is expected that all course participants:
