

BECOMING A VALUED SUPPLIER

From April 1st 2020 the current approach to the Standard List will cease and be replaced by the Valued Supplier scheme. Only Valued Suppliers products and services will be included in the new Valued Supplier Scheme 2020.

For existing suppliers, the process to become a recommended Valued Supplier is simple. By completing a short form you will be automatically included in the new scheme.

For new suppliers there is a Valued Supplier selection procedure. More information about this can be found at the end of this pack.



BECOMING A VALUED SUPPLIER

To make the managing of the Valued Suppliers sustainable we will be charging an annual fee of £1,800 (+ tax) that covers the cost of managing and marketing the services, plus make a contribution to help cover IAPB's core costs.



With a strong heritage, the new Standard list/ Valued Supplier Scheme is widely recognised as the go to procurement resource for NGO members and their partners, government bodies, trusts and large funders, charity and university eye hospitals.

We also have a growing interest from health ministries and are recognised by all the WHO regions. The products and services included within the Valued Supplier Scheme have been tried, tested and approved by our expert panels.

IAPB VALUED SUPPLIER SELECTION PROCEDURE

IAPB works with a range of Valued Suppliers who are selected for the quality of their products and services, value for money, experience of working with NGO's and sustainability.

In addition to our selection criteria below, we also expect all of our Valued Suppliers to act in a responsible business way and adhere to our Code of Conduct.

In order to have a successful Valued Supplier relationship the supplier must offer consistently good value to members. To make the managing of the Valued Suppliers sustainable we charge a fee that covers the cost of managing and marketing the services, bringing new services and offers to the market, plus make a contribution to help cover IAPB's core costs.

In evaluating a potential Valued Supplier IAPB will review the following to help assess suitability.

- Supplier has a bespoke member or sector offering that is competitively price
- Supplier understands values of the sector
- Take references (ideally from member organisations)
- Review evidence of funding and financial probity
- Supplier agrees to adhere to IAPB Code of Conduct
- Supplier has a complaints procedure/register
- Quality of the goods and services to be supplied
- Reliability of the supplier and their supply chain
- Safety aspects of the goods and services
- Maintenance and after sales support;
 overall service level that is offered

IAPB VALUED SUPPLIER REVIEW PROCEDURE

IAPB continually reviews its Valued Suppliers to ensure they are offering appropriate and good value services and products. Our review procedures include the following:

- An annual review with each supplier
- An annual survey of members who have used services from the Valued Suppliers
- A formal complaints procedure with each supplier and a complaint register of all complaints received



IAPB reserves the right to decide whether it thinks developing a Valued Supplier partnership with an organisation that meets the minimum criteria is in the best interests of IAPB and its members. IAPB works with Valued Suppliers as organisations that we recommend members consider for supplying products and services, IAPB offers no guarantees over the quality and appropriateness of any supplier for any particular organisation and every organisation should discuss their requirements with the Valued Supplier to ensure they meet their particular needs.
