## I Background & Goal




## Background

➤ Based on *The Notice on Activating the National Information Reporting System of Cataract Surgery by General Office of MoH* (WBYZF[2009]94), the system started to be used from July 1, 2009 in the whole country.

➤ The notice regulated: the medical institutions at all levels and types providing cataract surgeries should use the system. All cataract surgery information should be reported in 4 days from the surgical date.



## The Structure of the Reporting System of Cataract Surgery



## Goal

Make the evaluation on the quantity and quality of information reported by medical institutions at different levels and types, scientifically develop the national cataract surgery work, promote the sound development of blindness prevention and treatment, and provide basis for the governmental decision-making in cataract control.

Master the main situation of medical institutions, cataract surgeries, CSR in each province of China.



## **II Reporting Contents**



## **Reporting Contents**

- 1, medical institutions (location, level, type, character, contacts)
- 2. pre-surgery condition of patients (name, gender, age, relevant disease, surgical eye)
- 3. pre-surgery examination (visual acuity of naked eye, corrected visual acuity, intraocular tension, classification of cataract, pupil)
- 4. surgical condition (data of surgery, surgical procedure, with or without artificial lens implantation, surgical complications, source of surgical expenditure)
- 5 after-surgery condition (therapeutic evaluation after 3 days/3 months, after-surgery visual acuity of naked eye, after-surgery corrected visual acuity, complications)

#### 〇 "告别沙眼盲 关注眼健康"——2015年全国爱眼日宣传主题

2015年6月6日是第20个全国"爱眼日",今年"爱眼日"的活动主题为"告别沙眼盲,关注眼健康"。沙眼是世界卫生 组织重点防治的眼病之一。反复感染沙眼可以导致验结膜瘢痕及倒睫,从而对角膜造成损害,直至视力损伤、完全失 明。随着我国医疗服务体系的不断完善,医疗服务能力的持续提升,以及爱国卫生运动的全面开展,通过各地、各有 关部门和全国防盲治盲工作者的不懈努力,我国沙眼流行状况得到有效遏制。最新的沙眼流行病学调查结果显示,证 实我国已不再属于沙眼流行国家,已经实现了根治致盲性沙眼的目标。根治致盲性沙眼并不意味着不再有沙眼病例的 发生,仍需要继续普及沙眼防治知识,关注眼健康,防范沙眼流行的复燃。




## Types of Medical Institutions for Patients Visiting

general hospitals, specialized hospitals, hospitals of traditional Chinese medicine,


hospitals of traditional Chinese and Western medicine, hospitals of ethnic minority.






## Pre-surgery diseases of cataract patients
